Subject: Augmentation of Ambulances for COVID-19 activities in the Districts of Himachal Pradesh


This is regarding the requests being received from Districts and raised during the Video Conference held on 30th September 2020 regarding augmentation of ambulance services for COVID-19 activities in the districts.

In this regard, the National Health Mission has dedicated 47 ambulances of NAS-108 for transport of COVID-19 patients, 20 customised ambulances of 102-JSSK for COVID-19 sampling and 3 JSSK ambulances for dropback facility in District Kangra. The Department has conducted a review of the utilization of 102-JSSK ambulances and the additional underutilized 102-JSSK Vehicles (as mentioned at Annexure A) are hereby put at the disposal of Chief Medical Officers of respective Districts to be used for various sundry issues pertaining to COVID-19 like dropback etc.

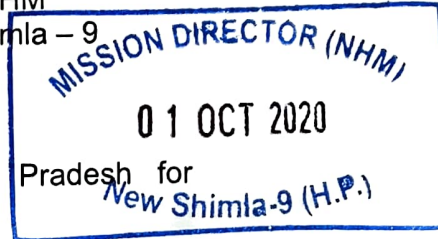
With regard to Hearse Vans, vide Letter No EMRT014/2/2019-NHMHP-3219 Dated 14-05-20, roadworthy vehicles which were earlier deployed in NAS-108 service have been conveyed to all Districts. And further 146 old ambulances under NAS -108 have been replaced and vide letter No NHMHP-EMRT014/2/2019- 2955 dated 08-04-2020, it has been conveyed regarding taking over of the old Ambulances from GVK EMRI. You are therefore requested to evaluate for the road worthiness of the taken over over ambulances and if found acceptable, those Vehicles can also be used for Hearse vans and additionally locally available Hearse Vans may also be used for the transportation of the posthumous COVID-19 Patients.

It is additionally requested that the departmental ambulances available with the districts may also be drafted for COVID-19 related responsibilities.


