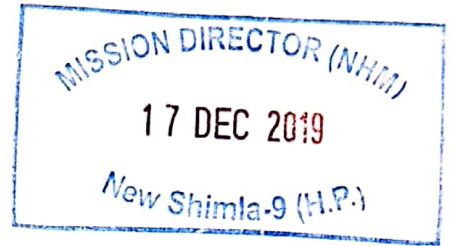

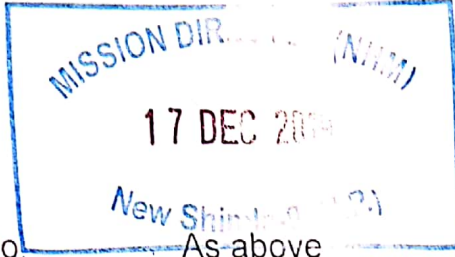
This is in continuation of our letter No. dated 5<sup>th</sup> October, 2010 and Corrigendum vide letter No. HFW-H/JSY(2006)-Loose-Vol.1 dated 20<sup>th</sup> December, 2017 (attached herewith for your reference).

The Government of Himachal Pradesh has upgraded JSY to "JSY Plus" and has revised the financial norms for disbursement of incentives as under:

FMR Code	Category	Existing Incentives	Revised Incentives
1.2.1.1.	Home Delivery in cases of BPL women	Rs. 500	Rs. 500
1.2.1.2.a	Institutional Deliveries in cases of BPL, SC, ST belonging to Rural Area	Rs. 700	Rs. 1100
1.2.1.2.b	Institutional Deliveries in cases of BPL, SC, ST belonging to Urban Area	Rs. 600	Rs. 1100

above.
