NOTIFICATION

Whereas, the State of Himachal Pradesh had earlier decided to pay Performance Based Incentives (PBIs) based on ten outcome indicators of health in four High Priority Districts, besides the normal salary for service providers or their team, vide letter number HFW-H/NHM/PBI/2015-16 dated 18.09.2015 and subsequently vide letter number HFW-H/NHM-PIP 2018-19 dated 27.12.2017

Whereas, the State of Himachal Pradesh had subsequently notified performance-linked incentive under National Health Mission for Gynaecologist, Paediatricians, Anaesthetists, Radiologists, Staff Nurse and Trained Dais serving in selected notified First Referral Units (FRUs) for improving the maternal health outcomes vide notification No. NHMHP-MTH0FRU/1/2019-MH section -NHM dated 26th December 2019.

Whereas, Team-based incentives are being disbursed to HWC's for 19 different indicators in the state that includes maternal & child health components too, notified vide NHMHP-HWC0PBI/1/2019-HWC-6059-63 dated 10th August, 2020.

Therefore, the performance based incentives permissible in the High Priority Districts, as issued earlier vide letter number dated 18th September 2015 and dated 27th Dec, 2017 stands withdrawn with immediate effect.
